## **Utility Commission Resignations:**

Motion made by Trustee Glass, seconded by Trustee Bardeen to accept the resignation from Harold Rodbourn for Chairman of the Utility Commission. All present were in favor and the motion was carried.

Motion made by Trustee Bardeen, seconded by Trustee Coots to accept the resignation from Mike Austin for Vice Chairman of the Utility Commission. All present were in favor and the motion was carried.

# **Appointments for Utility Commission:**

Motion made by Trustee Coots, seconded by Trustee Glass to appoint Mark Alger to the Utility Commission for a 5 year term. All present were in favor and the motion was carried.

Motion made by Trustee Bardeen, seconded by Trustee Coots to appoint Robert Plaskov to the Utility Commission for a 2 year term. All present were in favor and the motion was carried.

Motion made by Commissioner Plaskov, seconded by Commissioner Becken to amend the previous motion to authorize Chairman, Jeff Muller, and Vice Chairman, Mark Alger, to sign requisitions. All present were in favor and the motion was carried.
